PDC Mike Rusk, was the leadoff hitter at our first camp meeting of the year 2023. He delivered an excellent short program on the "Civil War Origin of Robert's Rules of Order." This was a subject that one

might ordinarily think had no connection to the Civil War, but it did.



The author, Henry M. Robert was a Union officer. Wikipedia says that "The author's interest in parlimentary procedure began in 1863 when he was chosen to preside over a church meeting and, although he accepted the task, he felt that he did not have the necessary knowledge of proper procedure." Loosely modeled after rules in effect in the United States House of Representatives, his first book was published in 1876 with the cover title of Robert's Rules of Order. With some revisions over the years, it has become the most widely used manual of parliamentary procedure in the United States.

Mike recited a rather humorous story of a dispute that arose between England and the US over San Juan Island off our west coast in the vicinity of Seattle that was valued for its strategic importance. The two sides set up camps at opposite ends of the island when a "Pig War" developed in 1859 over a farmer killing a pig for eating his potatoes. The pig owner offered in his defense that it was the responsibility of owner of the potatoes to keep them out of his pig's mouth.

Well...as Rex Griffin said, "You had to be there."



Anyway, the US sent an officer to the island to build a defensive redoubt on our end, and that officer was West Point graduate 2st Lt. Henry Martyn Robert. He built such a strong position that the English didn't challenge it. Lt. Roberts went on to become a general in the Army of the Potomac during the Civil War.

DC Clint Anderson emailed the camp, "Seneca Native Ely Samuel Parker was present at Appomattox and completed the final draft of the Confederate surrender. He was honored on the 2022 Native American Sacagawea dollar last year. Another neat piece of history from our passion."

PDC Rex Griffin added: "At the 150th Anniversary of the surrender at Appomattox, there was a five-day ceremony in which our then Commander-in-Chief, Tad Campbell, rang the bell which started bells ringing all over the country in remembrance. One of the honored guests that day was Ely Parker's G-G-G Grandson (not sure of the G's). Dressed like Parker for the ceremony, his descendant was the spitting image of his honored ancestor."

SUVCW Contributions Now Tax Deductible

Dept. Secretary William Andrews notified camp secretaries, "The SUVCW is now listed on the Internal Revenue Service Publication 78 ("Pub 78"), which is available online. Our letter of determination is also posted on the site. Of note, subordinate organizations (Departments, Camps, and SVR units), remain under the National Organization's umbrella.

"This is of great importance to our Order. Pub 78 is a document published by the IRS that lists organizations that are qualified to receive tax-deductible contributions, as described in Section 170(c) of the Internal Revenue Code of 1986.12. Pub 78 is the primary reference that donors use to check an organization's eligibility to receive tax-deductible charitable cash and non-cash contributions."

We are fortunate to have a new application for camp membership submitted by Mr. Robert Wilkerson, who we expect to attend our February meeting. He has submitted the supporting documentation and his dues check. Hopefully, his application will be found to be in order, and he will be voted into the SUVCW at the meeting.

We have been asked by the National Organization to react to a committee study that would change the wording of our Constitution and Regulations as to the meaning of 'male.' This word's importance has been magnified in recent times since it is a specification for membership admittance into our organization, and is sometimes accepted by society as something different from that determined at birth. This will be a topic of discussion at the February camp meeting.

For those who don't know, Johnny was a Navy Corpsman who did two tours in Vietnam patching up Marines. A Bob Hope show had come to his base, but he and 2-3 others had been "bad" and were restricted to the hospital during the show. The group of them were sitting around a table playing cards, Johnny with his back to the door, when, suddenly, the other guys all froze. Wondering what was going on, Johnny felt a hand on his shoulder and a woman's voice behind him said, "So you are the bad boys I was told about." It was Raquel Welch come to visit them in person. Johnny swore he would never wash that shoulder again.

Raquel Welch died Wednesday, at age 82. Johnny died March 31, 2021, age 75. May they both Rest In Peace.
